- (1) WB Township does not levy the 1% Administrative Fee or otherwise charge the SD for tax collection.
- (2) With the passage of Proposal A , all properties which qualify for a "Homeowner's Principal Residence Exemption" are exempt from the Local School District Operating Tax.

- (4) For 2006, 66.83% of the County Operating rate (2.8000) is levied in July and the balance (1.3900) in December.
